Due to a noticeable decrease in transient turbine aircraft traffic for July and in an effort to adjust the fee to better match local pricing; I am recommending to set the fees for \$50 Turbo Prop, \$50 Light Jet, \$75 Medium Jet, and \$100 Heavy Jet with similarly adjusted wavers for fuel. I have found recently that our current ramp fee's track along with private FBO's that offer more services to their customers and would not be well received locally by most transient traffic. The fees have not been published on line due to wanting to give them a trial period before making them more permanent.
