- 2. Security witnessed a confrontation between a homeless man and a probation officer in the lobby of C building. The confrontation was basically the probation officer asking the subject why he was in the lobby all day every day. after discussion with Sussan Epley, I talked to the subject and advised that he needed to stop being at DSS all the time and that if it continued at the same rate that he would be trespassed from the campus.
- 3. We had a subject known to be loud and disruptive visit building C in reference to his food stamp card. Security officer escorted him throughout his visit to our campus, this really helped according to staff.
- 4. Security was called about two subjects acting suspicious in the parking lot, security officer spoke with the subjects, and they left shortly after the conversation.
- 5. Security was called about a shirtless man in the parking lot.
- 6. Security talked to a subject at the bus stop who was talking very loudly to herself, officer stayed in the area until she left
- 7. Security ask a subject to leave after she had been in the lobby for well over an hour without any business on the campus.
- 8. Security officer was called to return to the campus while on lunch in reference to a subject threatening people. Subject was located at the bus stop and officer stayed with her until she left with transit.
- Security sat outside an office due to the client acting suspicious Until the meeting ended.
- 10. Security was called back from lunch due to a subject being loud and disruptive in the parking lot. Subject left walking when officer arrived.
- 11. Security checked o a vehicle that had been left overnight.
- 12. Security was called to B building parking lot in reference to a suspicious vehicle. The vehicle was an employee spouse waiting on his wife.
- 13. Security helped a customer jump start their vehicle.

- 14. Security was called to bring Narcan to B building in reference to two possible fentanyl exposure's the exposures happened off site. Once on-site security officer contacted EMS to respond and check out the staff members. They were not transported to the hospital.
- 15. Security assisted a customer jump start there vehicle
- 16. Security was called to the parking lot of A building in reference to a stray dog.
- 17. Security was called to A building in reference to DSS taking custody of two children and the mother being very loud and upset. Process took about two hours.
- 18. Security ask subject sleeping in the lobby if they were ok and had a ride coming.
- 19. Security assisted customer with a wheelchair to enter the building (DSS wheelchair)
- 20. Security assisted customer by calling Spindale police to come meet with him at DSS about missing money by his payee.
