#### I. Call to Order

Chairman King called the April 1, 2019 meeting of the Rutherford County Board of Commissioners to order.

Present: Chairman Bryan King, Vice Chairman Alan Toney, Commissioner Michael Benfield, Commissioner Eddie Holland, and Commissioner Greg Lovelace.

## A. Pledge of Allegiance

Isothermal Community College Vice President of Administrative Services Stephen Matheny led in the Pledge of Allegiance.

## B. Agenda Approval

Commissioner Lovelace moved to approve the agenda. Commissioner Benfield seconded the motion. The vote on the motion was:

## II. Public Hearing

#### A. ID 19-2010 Public Hearing on Economic Development Project

At 6:01 P.M. Chairman King opened the public hearing to listen to comments regarding Rutherford County's intent to consider the approval of a 5% match for a requested Building Reuse Grant. The grant would be used by Affinity Living Group to construct an assisted living facility in the Lake Lure area. The local match would not exceed \$25,000.

Economic Development President Tom Johnson told those present that the 62-bed facility will employ approximately 55 but only 27 of those positions will be qualifying jobs. The \$8,000,000 facility will encompass approximately 28,000 square feet. The Town of Lake Lure is very supportive of the project even though it is outside the town limits.

No one else wished to speak.

At 6:05 P.M. Chairman King declared the public hearing to be closed.

Commissioner Lovelace moved to approve the 5% matching grant request and authorize the County Manager, County Attorney, Finance Officer, Clerk to the Board, and other County officials to sign and execute all documents in support of this action. Vice Chairman Toney seconded the motion.

# A. ID 19-2022 Community Development Block Grant Neighborhood Revitalization Grant

Finance Director Paula Roach told the Board that Rutherford County has received a Community Development Block Grant (CDBG) Neighborhood Revitalization Grant in the amount of \$631,667. A Capital Project Ordinance which reflected the expenditures expected was presented for the Board's consideration. Director Roach said the Project Ordinance and the CDBG agreement must be executed and returned to Raleigh by April 14, 2019.

# CAPITAL PROJECT ORDINANCE PROJECT Community Development Block Grant – Neighborhood Revitalization Program CDBG 17-C-2988

BE IT ORDAINED by the Rutherford County Board of Commissioners that pursuant to Section 13.2 of Chapter 159 of the General Statutes of North Carolina, the following project ordinance is hereby adopted.

Section 1. The project authorized is the Community Development Block Grant –Neighborhood Revitalization Program No. 17-C-2988. The Project is financed with Community Development Block Grant (CDBG) funds administered by the North Carolina Rural Economic Development Division (REDD).

Section 2. The officers of this unit are hereby directed to proceed with the grant project within the terms of the grant documents, the rules and regulations of the State of North Carolina, and the budget contained herein.

Section 3. The following revenues are available to Rutherford County for this project:

Section 5. The Finance Director is hereby directed to maintain within the Grant Project Fund sufficient specific detailed accounting records to satisfy the requirements of the grantor agency, the grant agreements, and federal and state regulations.

Section 6. Funds may be advanced from the General Fund for the purpose of making payments as due. Reimbursement request should be made to the grantor agency in an orderly and timely manner.

Section 7. The Budget Officer is directed to include a detailed analysis of past and future costs and revenues on this grant project in each budget submission made to this Board.

Section 8. Copies of this grant project ordinance shall be furnished to the Clerk to the Board of County Commissioners, and to the Budget Officer and to the Finance Director for direction in carrying out this project.

## B. ID 19-2009 Lease with Cliffside Historical Society

County Manager Steve Garrison told the Board that the Cliffside Historical Society had approached the County with a proposal to extend their lease of the Clock Tower to include the former "Rescue Hut" cabin facility where a Cliffside museum facility would be created. Since receiving the proposal, the County has discussed the society taking on minor maintenance and basic grounds keeping of this facility.

Also presented was a letter from Rutherford County Rescue advising that they no longer have a use for the building. The group requested that they be allowed two months to remove all of their items which are stored at the building.

Mr. Phillip White said a similar lease is in place between the Cliffside Historical Society and Rutherford County for the clock tower in Cliffside.

Commissioner Benfield moved to approve the lease agreement negotiated by the County Manager and the County Attorney and authorize the County Manager, Finance Officer, Clerk to the Board, and other County officials to sign and execute all documents in support of this action. Commissioner Holland seconded the motion. The vote on the motion was:

#### C. ID 19-2011 Juvenile Crime Protection Council Resolution

The Juvenile Justice Reinvestment Act expands the age of juvenile jurisdiction, increasing it to include juvenile ages 16 and 17 years of age effective December 1, 2019. Chairman of the Juvenile Crime Protection Committee Steve Collins and Chief Court Counselor Rodney Wesson presented a resolution for the Board's consideration that requests additional state funding to ensure successful implementation of the act.

Commissioner Lovelace moved to approve the resolution. Vice Chairman Toney seconded the motion. The vote on the motion was:

# Rutherford County Board of Commissioners Resolution Supporting Juvenile Crime Prevention Council Allocation Expansion

**WHEREAS**, Juvenile Crime Prevention Council (JCPC) funding is a partnership between the State of North Carolina and the County to ensure a local continuum of services for court involved and at-risk juveniles; and,

WHEREAS, the Juvenile Crime Prevention Council, under the authority of NCGS§143B-851, and within the scope of its powers and duties, "Each County Council shall annually review the needs of juveniles in the county who are at risk of delinquency or who have been adjudicated undisciplined or delinquent and the resources available to address those needs. In particular, each County Council shall assess the needs of juveniles in the county who are at risk or who have been associated with gangs or gang activity, and the local resources that are established to address those needs," and,

**WHEREAS**, the Juvenile Justice Reinvestment Act passed in 2017, also referenced as North Carolina's Raise the Age legislation, expands the age of juvenile jurisdiction, increasing it to include juveniles ages 16 and 17 years of age effective December 1, 2019; and,

**WHEREAS**, Raise the Age legislation will increase the need for immediate and age-appropriate sanctions and diversion services for juvenile offenders and those at-risk of delinquency; and,

WHEREAS, JCPC funding has seen no increase in more than nine years; and,

**WHEREAS**, the effort to immediately and effectively address juvenile offending behavior is an evidence-based investment in North Carolina's future; and,

**WHEREAS**, effective intervention and programming reduces detention and youth development commitments as a cost savings to the state and county;

**NOW, THEREFORE BE IT RESOLVED**, that Rutherford County fully supports an adequate and timely increase of local Juvenile Crime Prevention funding from the State of North Carolina to ensure program expansion and successful implementation of the Juvenile Justice Reinvestment Act Raise the Age Legislation, set for December 1, 2019.

# D. ID 19-2012 Transit's System Safety Plan

Transportation Director Kerry Giles told the Board that the North Carolina Department of Transportation requires that the Board of Commissioners approve Transit's System Safety Plan annually. There have been no updates since the last approval.

## E. ID 19-2019 EMS Standard Operating Procedure

Director Giles said EMS is requesting Commissioner approval of a revision to their internal policy for the process of writing off charges. The update to the EMS Standard Operating Procedure is a revision of *Procedure #6, Process for Write Off of Charges* that would allow outside public safety

agencies to request dismissal, waiver or release by the County Manager of EMS charges for on-duty personnel who are injured during an emergency call. Outside public safety agencies provide service to EMS and to citizens during emergency situations. While it has been EMS' practice to invoice all patients for services rendered to create equality and transparency for all, EMS also understands that these agencies also provide EMS with services without payment.

Vice Chairman Toney moved to approve the revision to *Procedure #6, Process for Write-Off of Charges* in the EMS Standard Operating Procedure. Commissioner Benfield seconded the motion. The vote on the motion was:

## 6. Process for Write Off of Charges

EMS provides pre-hospital medical care, ambulance transports and invoices for services rendered on behalf of Rutherford County. EMS shall, whether directly or through third-party billing company contracted to provide such services, invoice all patients for services rendered. Any request for dismissal, waiver or release of a patient's EMS charges shall be made in writing to the County Manager. No employee of EMS or of any third-party billing company providing billing services on behalf of EMS, shall have any authority to dismiss, waive or release any bill for EMS services, which such authority shall reside with the County Manager or his or her designee.

In the event any employee, volunteer or other professional of any public agency providing professional public safety services, including but not limited to law enforcement, medical or fire, who is treated and/or transported by EMS as a result of injury or injuries sustained in the course of performing his or her duties in any emergency incident, his or her supervising agency may request dismissal, waiver or release of any bill for EMS services provided to said employee or volunteer by submitting a written request and copy of the invoice to the County Manager or his or her designee, who shall have full discretion to make such dismissal, waiver or release.
