# Recycling Challenges

A Federal, State and County Issue

#### General Overview

- Recycling is a federal, state and county issue. Federal and state governments are passing the costs to county governments.
- Declining market values.
- Contamination levels
- Reduced end markets
- Increased cost to process recycling.

#### Comparison Results

- Counties and municipalities have seen large increases in the cost of recycling.
- Counties are mandated to recycle because some items such as aluminum cans and plastic bottles are banned from landfills. Failure to comply could result in a Notice of Violation (NOV) and we would face fines and possible loss of future grants such as scrap tire grants, white good grants and e-waste.
- Some counties are going from single stream back to source separated.
- Some counties are changing their recycling stream to exclude glass or just recycle the items that are banned by the state.

#### Comparison Results Continued

- Counties are spending money on campaigns to lower contamination rates. NCDENR launched RecycleRightNC recently.
- Counties will continue to recycle in the future.
- All counties are dealing with the issue of how to cover the increased cost for recycling.
- Counties are having to pass the costs to citizens due to enterprise budgets not being able to absorb the costs.

#### How Counties are Covering Increased Costs of Recycling

- Some counties are absorbing the price increase with tipping fees on MSW.
- Some counties are increasing the user and availability fees.
- Some counties have set up a separate tipping fee for recycling.
- Some counties have a recycling fee for residents.
- Some counties are using general fund money.

#### Request for Proposals

- The county recently received two proposals from possible MRF's to process and haul our recycling.
- The lowest price came in at \$103.12 per ton for processing and hauling. The county is guaranteed a minimum of \$15.00 dollar return per ton as profit-sharing. Cost becomes \$88.12 for just processing and hauling. The county receives 85% of shared revenue based on the average material value of the stream after hauling, processing and residue has been disposed of.
- The other proposal was \$155.00 per ton for processing and hauling. The county is not guaranteed a minimum amount. The county receives 80% of shared revenue based on the average material value of the stream after hauling, processing and residue has been disposed of.
- Extremely hard to predict the average material value due to lower end markets and the uncertainty of the commodity market.

#### Recycling Expense

- The landfill staff is forced with finding a way to pay for recycling. Last year the county received 2793.12 tons of recycling. After receiving the RFP's the counties cost would be \$246,157.67 and this does not account for growth in the recycling stream which is roughly 375 tons per year.
- This is extremely alarming since the federal and state governments are passing the burden to county governments. Staff is forced to find a way to recycle while minimizing the impact on our citizens.

- Absorb all the costs within the current Enterprise Fund
- Enterprise fund does not have the money to cover these costs.
- Will have to significantly cut other services that we offer.
- Would have to rely on general fund for help which means we would not operate as a Enterprise Fund.

• Change the recycling stream to source separated.

- County will have to market their own recyclables.
- Large amount of costs for more employee's, trucks, containers, bailers
- Would require more building space.
- Very labor intensive and time consuming.
- Expensive on the front end

- Recycle only what the state has banned from the landfills.
  - Aluminum cans and plastic bottles.
- This is not good for the environment.
- Would increase the cost of MSW tonnage waste.
- Fill up landfills quicker.
- Impossible to get weights for shipping on recycling trailers.
- Confusion for citizens.

• Set up tipping fee and raise the availability fee

Availability fee would increase by \$15.00 per year and the tipping fee would be around \$115.00 per ton for municipalities.

- Tipping fee would be extremely higher than MSW rate.
- Availability fee would increase significantly.
- Would have to adjust fee each year.
- Participation will reduce.
- Material stream could change.

- Charge all improved properties a recycling fee.
- The recycling fee would be \$7.00 per year.
- Roughly 58 cents per month to recycle and save our natural resources.

- Smallest impact on citizens.
- Still promotes recycling.
- Operations would stay the same.
- No reductions in the type of items recycled.
- Would continue to take recycling free from in county municipalities.

• Any other option that the county manager or commissioners may have.

#### Staff Recommendation

- Approve option #5.
- Has the least impact on citizens. Charged to all improved properties.
- Only \$7.00 per year or roughly 58 cents per month.
- Operations and recycling stream will remain the same.
- County and citizens are helping to save natural resources and the environment.
- In county recycling would not have a tipping fee charge.
