Pursuant to Rutherford County EMS' SOP 134, EMS is requesting that the EMS Accounts Receivable uncollectible balances below be written-off. This adjustment reflects implementation of this policy as adopted June 8, 2018 by County Commissioners. The request below reflects only accounts that are uncollectible due to the patient not have an estate, bankruptcy, or timely filing issues with insurance. Earlier this year we changed our policy from the Medicare's 7 year retention timeframe to NCGS Chapter 44, Article 9B and NCGS 105-378(a) which has a debt retention of 10 years. Therefore, we will not have a large amount to write off for three years.

We are requesting that \$12,799.41 be written off as uncollectible. Attached is a copy of the report detail.
