On September 23, 2021, public bids were opened and read aloud at the Rutherford County Administration offices for the above referenced project. Five (5) bids were received with the apparent low bid submitted by Site Development Corporation of Cliffside, North Carolina for a total bid price of \$673,755.00. Attached is a certified bid tabulation with the details for all the bids received.

Site Development Corporation holds an Unlimited, Unclassified General Contracting License with the North Carolina Licensing Board for General Contractors, therefore they are properly licensed to perform the scope of work associated with this project. Site Development Corporation submitted a complete bid package and has previously completed the Thermal Belt Rail Trail Project in Rutherford County with them as General Contractor.

McGill Associates recommends that Rutherford County award the construction contract to Site Development Corporation, for a total base bid amount of \$673,755.00. The certified bid tabulation and a copy of Site Development Corporation's bid is attached to this letter for reference.


