## **II. Public Hearings**

A. ID 17-1364 Public Hearing - Budget for Fiscal Year 2017-2018

At 6:03 P.M., Chairman King opened the public hearing to listen to comments regarding the recommended Rutherford County Budget for Fiscal Year 2017-2018.

County Manager Steve Garrison told those present that the total general fund recommended budget is \$63,412,423, and the total recommended budget for all funds is \$82,431,547. The tax rate will remain at 60.7 cents per \$100 valuation. A rate increase of two cents was originally proposed; however, Commissioners expressed concern because Rutherford County is still an economically distressed county. Operational funding will remain the same with the schools, the college, and the County receiving a 1.87% increase. Additional fund balance will be budgeted..

The Solid Waste Enterprise Fund will require an increase in revenues in order to fund operations and a study that will insure the sustainability of the solid waste fund.

Mr. Michael Jennings of Ellenboro expressed his concern regarding the increase in the tax for the Ellenboro Fire District. He also suggested that salaries of County employees be reduced 20% instead of raising taxes.

Ms. Tracy Williams, Executive Director of Youth Empowerment, told the Board that this

organization had provided services to the County for 18 years. Their services include advocating for kids, summer programs for youth, and an afterschool program. Youth Empowerment stands in the gap for high risk children. Ms. Williams asked that the Board fund a \$10,000 match required for the Juvenile Crime Prevention Committee grant.

Mr. Melvin James described the impact Youth Empowerment had on his life. The program had helped push him to attain a 4.4 GPA at East Rutherford High School. He will graduate with an associate degree next year.

Mr. Trinity Simpson said his mother had entered him in a summer program at Youth Empowerment due to a lot of drama that occurred in his life. This opened the door for him and changed his life. He has a 12-year perfect attendance record at his school.

Ms. Page Waters began attending Youth Empowerment programs a few months ago. Her life had included some bad experiences due to her actions. She now has matured and is making A's and B's in her sophomore year at RS Central.

Finance Director Paula Roach told the Board that Rutherford County received a Community Development Block Grant (CDBG) Water Infrastructure Improvement Grant. She presented a Project Ordinance which reflected the expenditures expected with the project. The local funds from BRWA will be used to cover the costs of the homes to be impacted that do not meet the low to moderate income limits required by the CDBG. Any other cost overruns for grant administration would also be the responsibility of BRWA. An interlocal agreement with BRWA is currently in draft form and plans are to present it for consideration at the July meeting.

Director Roach said the Project Ordinance and the CDBG agreement must be executed and returned to Raleigh by June 8th as required by the State.
