A. <u>ID 18-1768</u> Announcement of Vacancy on Rutherford County Tourism Development Authority

A. <u>ID 18-1769</u> North Carolina Department of Transportation Prioritization for Projects Presentation

Ms. Stephen Sparks, NCDOT Division 13 Corridor Development Engineer, provided information on NCDOT's STI (State Transportation Investments) Prioritization and Programming Process. House Bill 817 which was signed into law in June of 2013 is the most significant NC transportation legislation since the 1989 Highway Trust Fund. This created a prioritization workgroup to provide recommendations to NCDOT on weights and criteria for transportation projects in the state. The projects are a result of long-range planning (Comprehensive Transportation Plans), prioritization, and project funding (State Transportation Improvement Program.)

Mr. Sparks said the work group meets every two years and sets the methodology of scoring. County Manager Steve Garrison noted that when the new scoring mechanism was created, it became very difficult for rural counties to receive any funding for paving. Chairman King stated that the Board's desire is for equitable treatment for all citizens, and he asked that Mr. Sparks relay this message to the Raleigh headquarters.

NC Written Regulations

Rutherford County Commissioners -Local Authority October 1 2018

Ms. Karen Caldwell, Regional Tobacco Control Manager of the Division of Public Health, Tobacco Prevention and Control Branch of the North Carolina Department of Health and Human Services, presented information on developing and implementing a smoke/tobacco free policy to the Board. A local government may adopt and enforce ordinances, board of health rules, and policies restricting or prohibiting smoking that are more restrictive than state law and that apply to:

- · Local Government Buildings
- · Local Government Vehicles
- · Local Government Grounds
- Enclosed Public Places

The Board of County Commissioners may adopt an ordinance that applies to unincorporated areas. If municipalities agree, the ordinance may apply within incorporated areas. Presently, Rutherford County has no 100% tobacco-free or smoke-free written regulations.

Finance Director Paula Roach advised that the Juvenile Crime Prevention Council had recommended the transfer of equipment previously utilized by Youth Empowerment to Project Challenge and Kids at Work. Two items that were not requested will revert to the County. The Finance Office and Public Works will coordinate with the regional JCPC programs manager to transition the equipment, if approved.

Project Challenge requested the 2010 Chrysler Town & Country since the van that Project Challenge is using is a 2006 which was purchased by Polk County and has over 137,000 miles. Kids at Work has requested all the kitchen equipment to set up their own kitchen, the 15-passenger van to exclusively transport Rutherford youth and their families for services, and the laptops and mini-computers that would help in curriculum delivery with students, especially as they implement ServSafe certification for students which utilizes online materials and testing.

Funding previously awarded to Youth Empowerment for FY 2018-2019 will be included in the County Commissioners' December meeting agenda for reallocation.

Commissioner Holland moved to approve the transfer of equipment as recommended by the JCPC board. The two items unclaimed will be transferred to the County. If equipment cannot be used, staff will recommend disposition as appropriate and any program revenues will be repurposed for JCPC programs. Commissioner Benfield seconded the motion.
