Executive Directors Willard Whitson of KidSenses provided an update on the new FACTORY site which is under construction. KidSenses Children's Interactive Museum which opened in 2004 has approximately 30,000 visits per year. This infuses the Town of Rutherfordton with vitality and brings needed revenue to the community – approximately \$300,000 per year for area businesses.

The FACTORY, KidSenses and Discovery Garden will comprise a 27,000 square-foot campus and double the attendance to 60,000. It will be a place where youth ages eleven into their teens will find stimulating activities and opportunities to learn and grow.

County Manager Steve Garrison said a current North Carolina General Statute requires that new voting equipment be purchased by counties by December 1, 2019. Presently there is only one choice that has been approved by the State Board of Elections and it is not ADA compliable. A Congressional bill requires new equipment by 2022 and may have new requirements for technology.

A resolution provided for the Board's consideration urged the General Assembly to enact legislation that would allow the State Elections Board more time to certify newer, more modern, and more diverse technology for voting machines and allow for synchronization with Federal elections regulations reducing the risk of duplication of costs within a 4-year window.

A letter was included in the agenda from the Rutherford County Board of Elections stating concerns regarding the timing of the purchase of new voting equipment.

Manager Garrison pointed out that if the purchase is delayed, the cost of hardware and software license fees which is \$42,898 will have to be paid for another year, and this was not included in the budget.

A resolution confirming the membership with McDowell County in a district health board that would become effective immediately after midnight on June 30, 2019 was presented for the Board's consideration. North Carolina General Statute 130A-37(d) states that whenever a county shall withdraw from an existing district health department, the district board of health shall be dissolved, and a new board shall be appointed. The county board of commissioners of each county in the district shall appoint one county commissioner to the district board of health. The county commissioner members of the district board of health shall appoint the other members of the board. Commissioner Lovelace who is currently serving as the Rutherford County Commissioner on the present health board had indicated his willingness to serve on the Foothills Health District Board of Health.

In addition, section (d) of 1407 states the Board of County Commissioners may appoint a maximum of five additional members to represent county agencies or the community at large. A list of the current membership was presented with the report, including what organization or CCPT/CFPT position that each member represents. Historically, the team has appointed members to these five County Commissioner-appointed positions as needed and then presented the list to the Board annually for approval, or to make changes as the Board may deem necessary. There is no time limit on the appointments. County Commissioner appointments recommended by the team were Dr. Christian Burley, Ms. Lamonda Davis, Ms. Yanet Cisneos, and Ms. Stephanie Ingle.

Solid Waste Director James Kilgo told the Board that Rutherford County has a contract with Republic Services through June 30, 2020 to accept recycling from convenience centers, municipalities, and out-of-county municipalities and private haulers. Presently all in-county recycling is free and all of-of-county recycling is \$10 per ton.

There are challenges to the recycling program which are increased costs from material recovery facilities, fewer material recovery facilities accepting material, increased contamination levels, and declining market values.

Director Kilgo recommended that the existing contract with Republic Services be amended to allow Republic Services to bill Rutherford County \$115 per ton for out-of-county recyclables only. Rutherford County's tipping fee rate would increase from \$10 per ton to \$130 per ton to begin July 1, 2019.

## M. <u>ID 19-2031</u> Budget Presentation for 2019-2020

County Manager Steve Garrison presented the recommended budget for Fiscal Year 2019-2020. The total general fund budget was proposed at \$69,522,828 with the total budget for all funds coming in at \$83,448,091. The recommended tax rate was a reduction to 59.70¢ per \$100 valuation. The proposed budget includes an overall percentage increase of approximately 9.33% for the county, the Rutherford County School System, and Isothermal Community College. There is no appropriation of fund balance in the proposed budget.

Manager Garrison announced that once all of the budget requests were received from Isothermal Community College, the Rutherford County School system, the County Departments and community partners, the total amount of county funds requested was \$80,729,025, which left an initial gap of revenues needed to cover the requested expenditures of \$13.3 million. Currently, the value of one penny of the tax rate is \$626,781. To accommodate this increase to the budget would have required the addition of approximately 21.12¢ to the tax rate, increasing the current tax rate of 60.70 to 81.82 cents per each \$100 of appraised value.

The projected revenues for FY2019-2020 continues to be inadequate to address all of the critical operational, capital facility, equipment and technology needs of the County, the school system, and the Community College. However, the primary goals of the proposed FY 2019-2020 budget is to eliminate the use of Fund Balance from the General Fund to balance the budget, to ensure the County has the financial capacity and levity to adjust for inflation each year until the next revaluation cycle and to further support education.

Factors influencing the budget were :

- General inflation across departmental budgets
- Rollout of pay class study phase 3 of 3 and annual Cola
- Increase in number of DSS protective services cases
- Increase in Isothermal Planning and Development Commission annual dues
- Increase in Regional Health Center allocation
- Increase in rates for employee insurance and retirement benefits
- Critical capital facility, equipment and IT needs
- RCS and Isothermal Community College operational and capital budget requested increases

The Rutherford County School system identified approximately \$5.5 million of additional operational and capital facility needs for FY2019-2020 (a 36.4% increase) and ICC identified approximately \$3 million in additional operational and capital facility needs (a 37.65% increase, which includes their additional critical capital outlay needs identified in their capital facility plan, which they do not anticipate using NC Connect bond funds or other funding sources to address). The school system continues to face a funding deficit for their State-mandated Exceptional Children programming due to a state cap in the percent of student population served. Currently, students meeting the criteria for placement in the Exceptional Children programming represent 17.1% of the school

system's allotted average daily membership but the State only provides funding for this mandated programming up to 12.75%.

The revenue neutral property tax rate is 55.35¢ per \$100 assessed value. The revenue neutral adjusted property tax rate is 57.34¢. The actual revenue-neutral rate will not be confirmed until after the Board of Equalization and Review completes their work and all exemption applications are completed in late May.

Though no fee increases were recommended, the Solid Waste Enterprise Fund Budget had many challenges:

- · Electronics recycling
- White goods recycling
- Tire disposal and recycling
- Oil/filter recycling
- Addressing capital facility needs
- Waste hauling service contract increasing by 2%
