A. ID 20-2615 Partners Behavioral Health Management Update

Community Engagement Director Tara Conrad of Partners Behavioral Health Management provided on update to the Board on Partners' Supporting Rutherford County Year 1 (7/1/19 – 6/30/20). Partners served 3201 members which did not include those receiving treatment while incarcerated during this period, and the Medicaid penetration

rate increased from 6.9% to 15.8% meaning more individuals are getting connected to treatment

Partners contracted with 206 providers to serve Rutherford County members, and 22 of these providers are located in Rutherford County. Of the 3,128 Rutherford County members who received services, 1,830 received services in Rutherford County. The total amount expensed was \$25,632,010.09.

Partners has been addressing the opioid addiction by helping recruit and fund two local recovery houses and by supplying Narcan to first responders. The year has been very fruitful as Partners has increased the number of individuals receiving treatment, increased available treatment options, increased community engagement activities, supported new programs in the County, and actively engaged community members and leaders in identifying needs and use of local funds.

County Manager Steve Garrison pointed out that Rutherford County now has a County representative on the Partners' Board of Directors, and Partners collaborates with Rutherford County regarding the use of Maintenance of Effort funds appropriated by the County.
