A. ID-25-4238 Public Hearing – 5310 Elderly Individuals and Individuals with Disabilities Grant

At 6:02 P.M. Chairman King opened the public hearing to listen to comments regarding the application by the Senior Center for the 5310 Elderly Individuals and Individuals with Disabilities grant through the Federal Transportation Administration and NCDOT.

Senior Center Director Tammy Aldridge told those present that the goal of these funds is to provide transportation services that meet the special needs of elderly persons for whom transportation

services are unavailable, insufficient or inappropriate. The Rutherford County Senior Center will contract with Rutherford County Transit to provide daily transportation services to the Senior Center. This request requires a 10% local match which will be requested in the Senior Center's budget request for FY 26-27. A resolution approving the proposed 2027 Community Transportation Program Application was provided for the Board's consideration.

Transit Director Kerry Giles said this is an annual grant application process. The Community Transportation Program provides assistance coordinating existing transportation programs operating in Rutherford County as well as provides transportation options and services for the communities within this service area. These services are currently provided using 15 passenger vans and LTV buses. Services are rendered by Rutherford County Transit.

C. ID-25-4240 Public Hearing – An Ordinance Approving Changing the Street Names of Certain Roadways

At 6:08 P.M. Chairman King opened the public hearing to hear comments regarding street names of certain roadways in Rutherford County.

County Attorney Richard Williams told the Board that the construction of the new US Highway 221 has resulted in the altering and changing of numerous roads within Rutherford County. The Town of Rutherfordton submitted to the E911 Addressing Department petitions to change the street names of a portion of Rock Road to Katydid Court, Long Road to Hillstead Way, Old US 221 to Harmony Ridge, Laurel Hill Drive to Veterans Run, and Laurel Hill Drive to Promise Lane. The estimated cost for the proposed changes has been received from the Town of Rutherfordton. An ordinance approving the road name changes was included for the Board's consideration.

No one else wished to speak.

At 6:16 P.M. Chairman King closed the public hearing.

An Ordinance Approving Changing the Street Names of Certain Roadways

WHEREAS, construction by the North Carolina Department of Transportation of the new United States Highway 221 (hereinafter the "Project") through Rutherford County will bring numerous benefits to the citizens of Rutherford County through increased opportunities for economic development and safer travel, and has resulted in the altering and changing of numerous Roadways within Rutherford County;

WHEREAS, as a direct result of the construction of the Project, the courses of numerous existing Roadways have been altered and, in certain instances, individual roads have been divided into separate sections with limited street closures resulting in no access between them or with other Roadways to which they had formerly had access, all of which may cause confusion and delay in cutoff from previous access points to other Roadways;

WHEREAS, a comprehensive and consistent E911 addressing system for the naming and addressing of Roadways in Rutherford County maximizes public safety by ensuring that emergency responders, including law enforcement, emergency medical services and fire departments, have the ability to easily and readily locate those requiring their assistance;

WHEREAS, the Town of Rutherfordton submitted to the Rutherford County E911 Addressing Department a certain Petition for Road Name to change the Street Name of a portion of the Public Street presently known as Rock Road to **Katydid Court** as shown on map attached hereto as Exhibit "A";

WHEREAS, the Town of Rutherfordton submitted to the Rutherford County E911 Addressing Department a certain Petition for Road Name to change the Street Name of a portion of the Public Street presently known as Long Road to **Hillstead Way**, as shown on map attached hereto as Exhibit "A";

WHEREAS, the Town of Rutherfordton submitted to the Rutherford County E911 Addressing Department a certain Petition for Road Name to change the Street Name of a portion of the Public Street presently known as Old U.S. Highway 221 to **Harmony Ridge** as shown on map attached hereto as Exhibit "B":

WHEREAS, the Town of Rutherfordton submitted to the Rutherford County E911 Addressing Department a certain Petition for Road Name to change the Street Name of a portion of the Public Street presently known as Laurel Hill Drive to **Veterans Run** as shown on map attached hereto as Exhibit "C";

WHEREAS, the Town of Rutherfordton submitted to the Rutherford County E911 Addressing Department a certain Petition for Road Name to change the Street Name of a portion of the Public Street presently known as Laurel Hill Drive to **Promise Lane** as shown on map attached hereto as Exhibit "A";

WHEREAS, the Rutherford County E911 Addressing Department has determined each of these five requested Street Name changes are in the best interests of public safety and of public convenience and are necessitated by the alteration of Roadways due to the Project;

WHEREAS, the Department has received from the Town of Rutherfordton the estimated costs for each of the proposed changes to Street Names for which they filed a Petition;

WHEREAS, the Board of Commissioners of Rutherford County caused notice of the time, place and subject matter of a public hearing on this matter to be posted at the Rutherford County Courthouse and two public places in Rutherfordton Township where all five of the roads are located, to wit: at the Rutherford County Administrative Building, and at the Rutherfordton Town Hall;

WHEREAS, notice of a public hearing regarding the changes to each of the five Street Names was published in *The Daily Courier* a minimum of ten (10) days prior to the public hearing; and

WHEREAS, the Board of Commissioners of Rutherford County conducted a public hearing at

the regular meeting on September 8, 2025, on the subject of the proposed changes to Street Names of the aforementioned roads to, respectively, Katydid Court, Hillstead Way, Harmony Ridge, Veterans Run, and Promise Lane.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF RUTHERFORD COUNTY THAT, pursuant to Section 3-118(d) of the Rutherford County Code of Ordinances, the changes to Street Names for certain Roadways are approved, as follows:

- (1) A portion of Rock Road shall be changed to Katydid Court as shown on the phot marked "AFTER" on Exhibit "A" attached hereto.
- (2) A portion of Long Street shall be changed to Hillstead Way as shown on the photo marked "AFTER" on Exhibit "A" attached hereto.
- (3) A portion of Old US Highway 221 shall be changed to Harmony Ridge as shown on the photo marked "AFTER" on Exhibit "B" attached hereto.
- (4) A portion of Laurel Hill Drive shall be changed to Veterans Run as shown on the photo marked "AFTER" on Exhibit "C" attached hereto.
- (5) A portion of Laurel Hill Drive shall be changed to Promise Lane as shown on the photo marked "AFTER" on Exhibit "C" attached hereto.
- (6) Each of the Street Name changes approved hereby shall be made effective the 1st day of January, 2026.
- (7) The County Manager, pursuant to Section 3-118(d) of the Rutherford County Code of Ordinances and N.C. Gen. Stat. Section 153A-239.1 and working with the E911 Addressing Department and its Standard Operating Procedures, shall ensure that written notice be sent within ten (10) days by first class U.S. Mail to each owner of any parcel located upon each of the above affected Roadways, to the U.S. Postmaster for the affected postal code(s), to the North Carolina Department of Transportation, and to any municipality located within five miles of each of the above affected Roadways.

D. ID-25-4241 Public Hearing – An Ordinance Approving Changing the Address Numbers on Gilboa Church Road

At 6:17 P.M. Chairman King opened the public hearing to hear comments regarding changes in address numbers on Gilboa Church Road.

Ms. Doherty advised that the construction of the new US Highway 221 had brought about the changing of E911 Addressing address numbers on Gilboa Church Road. The southern end of Gilboa Church Road had been blocked resulting in changing address numbers to meet standards required in the Rutherford County ordinance for approximately 50 parcels. An ordinance approving the address number changes was included for the Board's consideration.

Chairman King invited member of emergency agencies who were present to respond to this possible action since it would cause some efforts on the residents to make the changes. Representatives from E-911, EMS, and the Sheriff's Department indicated there would be little effect in their response to calls on the road if the address numbers remained the same.

Mr. Mike Dalton said the Rutherford County budget cycle had been completed. The school system had expressed their concerns about a \$6.1 million shortfall for the schools during this cycle and asked for additional funds that would have required an increase in property taxes. Mr. Dalton reported that the school system had received \$90 million in state and federal assistance last year. Even with these additional funds, the school system advised that it was struggling to stay afloat. In comparison Rutherford County's budget was approximately \$80,000. Mr. Dalton stated his intent to become more involved in future budget cycles.

2025 NCACDSS Innovation Award

Presented at the 22nd Annual NCACDSS Innovation Awards, this recognition celebrates the innovative efforts to improve outcomes for foster children in North Carolina.

2025 Civic Excellence in Innovation Award

Awarded by the North Carolina Association of County Commissioners, this honor was officially presented at the 118th NCACC Annual Conference on August 21, 2025. It highlights the department's commitment to civic innovation and excellence in service.

These awards were made possible through the success of "Share for Foster Care," supported by a Dogwood Health Trust Grant, which led to the creation of "The Lighthouse at Building D" on the DSS campus - a dedicated, child-friendly space that ensures no foster child ever has to sleep on the floor of the DSS offices again.

VI. Commissioner Reports

A. ID-25-4250 Potential Impacts to Rutherford County if North Carolina Withdraws from SNAP

DSS Director Delores Hunt provided an update on the federal impact on the Medicaid and SNAP programs on Rutherford County should North Carolina opt out of the Supplemental Nutrition Assistance Program (SNAP). The most recent data from **June 2025** illustrates just how significant this program is to Rutherford County's local community:

Participants: 12,600Households: 6,587

· FNS Benefits Issued: \$2,081,846

According to the U.S. Department of Agriculture (USDA), every dollar issued in SNAP benefits generates between \$1.50 and \$1.80 in economic activity. This impact is realized through grocery retailers hiring and paying staff, replenishing inventory, and covering operational costs like utilities. Applying this multiplier to June 2025 benefits issuance:

At \$1.50: \$3,122,769 in local economic impact · At \$1.80: \$3,747,322.80 in local economic impact

This represents a significant monthly contribution to Rutherford County's economy. Opting out of SNAP could have a ripple effect on other USDA-supported programs as well, including free or reduced-price breakfast and lunch programs in our school systems, and summer feeding programs. These initiatives are vital to the health and well-being of Rutherford County's children and families.

Finally, several other benefits and services use SNAP participation as a gateway for **automatic enrollment**. For example, SNAP participants are automatically enrolled in other programs such as WIC, LEIAP, etc. Discontinuing SNAP would likely complicate access to these essential supports for eligible residents.

WHEREAS, the opioid overdose epidemic has taken the lives of more than 36,000 North Carolinians; and

WHEREAS, the Centers for Disease Control and Prevention has estimated the total economic burden of prescription opioid misuse alone in the United States to be \$78.5 billion a year, including the costs of healthcare, lost productivity, addiction treatment, and criminal justice involvement; and

WHEREAS, due to the opioid crisis taking an enormous toll on the people and families of Rutherford County, as well as impacting Law Enforcement, Emergency Management and Human Services; the high percentage of children entering foster care as a result of substance abuse by a parent or parents; the human impact on parents, spouses, children, siblings and friends who witnessed and experienced the suffering and death of loved ones; and the fiscal impact to Rutherford County related to health care costs, jail administration and incarceration, emergency management services, child welfare and public assistance; on December 14, 2017, the Board of Commissioners of Rutherford County passed a resolution at a special meeting to authorize investigation and legal action against opioid manufacturers and distributors engaged in the unlawful practices in the marketing and selling of opioids to seek their contribution in resolving the opioid crisis to which they contributed; and

WHEREAS, Rutherford County subsequently joined many counties and municipalities in North Carolina and thousands of local governments across the country to file lawsuits against opioid manufacturers, pharmaceutical distribution companies, and chain drug stores to hold those companies accountable for their misconduct; and

WHEREAS, the litigation against opioid manufacturers, pharmaceutical distribution companies and chain drug stores has previously resulted in settlements agreed by many of these companies that have provided millions of dollars that have and will come to Rutherford County to be used towards healing the damage the opioid crisis has wreaked upon the people of Rutherford County; and

WHEREAS settlements (collectively "the Secondary Opioid Manufacturer Settlements") have been reached in litigation against Alvogen, Inc., Amneal Pharmaceuticals LLC, Apotex Corp., Hikma Pharmaceuticals USA Inc. f/k/a West-Ward Pharmaceuticals Corp., Indivior Inc.,

Sun Pharmaceutical Industries Inc., Viatris Inc., and Zydus Pharmaceuticals (USA) Inc., as well as their subsidiaries, affiliates, officers and directors (collectively "the Secondary Opioid Manufacturer Defendants") named in the Secondary Opioid Manufacturer Settlements; and

WHEREAS, representatives of local North Carolina governments, the North Carolina Association of County Commissioners, and the North Carolina Department of Justice have negotiated and prepared a Third Supplemental Agreement for Additional Funds (SAAF-3) to provide for the equitable distribution of the proceeds of these settlements; and

WHEREAS, settlements have been reached, under Purdue Pharma L.P.'s bankruptcy plan, whereby Purdue Pharma, L.P. ("Purdue") and members of the Sackler family will pay approximately \$7.4 billion to settle opioid claims across the nation, which settlements would be subject in North Carolina to the equitable distribution of the proceeds as set forth in the Memorandum of Agreement ("MOA") which has already been approved by this Board; and

WHEREAS, by joining the Secondary Opioid Manufacturer Settlements, approving the SAAF-3, and approving the bankruptcy plan and settlements related to Purdue and the Sackler family, the state and local governments maximize North Carolina's share of opioid settlement funds to ensure the needed resources reach communities, as quickly, effectively, and directly as possible; and

WHEREAS, it is advantageous to the citizens of Rutherford County and to all North Carolinians for local governments, including Rutherford County, to sign onto the Secondary Opioid Manufacturer Settlements, SAAF-3, and approving the bankruptcy plan and settlements related to Purdue and the Sackler family, in order to demonstrate solidarity in response to the opioid overdose crisis, and to maximize the share of opioid settlement funds received both in North Carolina and here in Rutherford County to help abate the harm; and

WHEREAS, both the MOA and SAAF-3 directs substantial resources over multiple years to local governments on the front lines of the opioid overdose epidemic while ensuring that these resources are used in an effective way to address the crisis;

WHEREAS Rutherford County has joined national settlement agreements with companies engaged in the manufacturing, distribution, and dispensing of opioids.

WHEREAS the allocation, use, and reporting of funds stemming from these national settlement agreements and bankruptcy resolutions ("Opioid Settlement Funds") are governed by the Memorandum of Agreement Between the State of North Carolina and Local Governments on Proceeds Relating to the Settlement of Opioid Litigation ("MOA") and by three additional Supplemental Agreements for Additional Funds from Additional Settlements of Opioid Litigation (collectively, the "SAAF's");

WHEREAS Rutherford County has received Opioid Settlement Funds pursuant to these national settlement agreements and deposited the Opioid Settlement Funds in a separate special revenue fund as required by section D of the MOA;

WHEREAS section E of the MOA limits the use of Opioid Settlement Funds to specifically approved strategies falling under Option A or Option B, with additional requirements for those strategies identified as Option B; and

WHEREAS, Rutherford County retained R. Scott Luetgenau dba Gatespring to provide and assist in collaborative strategic planning, project management and technical assistance in the planning, management and delivery of projects employing Opioid Settlement Funds held by Rutherford County in a manner to best combat opioid use disorder and its impacts on the Rutherford County community in full compliance with the MOA and SAAF's; and

WHEREAS, R. Scott Luetgenau dba Gatespring has undertaken research, site visits, and conversations with those affected by opioid abuse and has engaged in the collaborative strategic planning process required by the MOA for Option A and Option B activities for use of the Opioid Settlement Funds; and

WHEREAS, R. Scott Luetgenau dba Gatespring has presented fifteen (15) potential activities balanced to address prevention, treatment, harm reduction and recovery support and authorized by Option A and Option B under the MOA, these activities being recommended to best meet the specific needs of Rutherford County and its citizens in fighting opioid use disorder and those closely affected by it, including the addicted, their families, health care and mental health professionals, law enforcement, the judicial system, and the community at large; and

WHEREAS, the Board of Commissioners for Rutherford County desires to accept the recommendations as presented in order to proceed to identify the best opportunities to engage in these activities through the use of the Opioid Settlement Funds pursuant to the MOA and the SAAF's.

NOW, THEREFORE BE IT RESOLVED, in alignment with and pursuant to the NC MOA and SAAF'S, the Board of Commissioners of Rutherford County accepts the fifteen (15) prioritized strategies under Option A and Option B as set forth on the Gatespring Brief presented by R. D. ID-25-4246 Annual EMS Reconciliation of Debt

K. ID-25-4251 New Criminal History Record Check Requirements for Come County and City Job Applicants

Attorney Richard Williams advised that a new state law was enacted this summer that will soon require all counties and cities in North Carolina to subject all applicants for positions that require working with children in any way to criminal history record checks conducted by the North Carolina State Bureau of Investigation (SBI). These new requirements will become effective October 1, 2025.

Attorney Williams recommended that the following be included in the Rutherford County Personnel Policy.

Section 3. Recruitment, Selection and Hiring [to follow "References and Background Investigations"]

Required Criminal History Record Check. Pursuant to N.C. Gen. Stat. 153A-94.2(b), before a commitment is made to any applicant for a position that requires work with children in any capacity, the County must conduct a criminal history record check by the North Carolina State Bureau of Investigation in accordance with N.C. Gen. Stat. 143B-1209.26. Any offer of employment of the position to the applicant must be conditional pending the results of the criminal history record check required herein. For the purposes of this section, "children" shall be defined as persons under the age of 18 years and is not married, emancipated or a member of the Armed Forces.
