ID 24-3695 Hangar 3A/3B Transfer

A Resolution which authorized the transfer of Hangar 3A and 3B from Philip O'Reilly to Casey Keating for \$120,000 contingent upon the execution of an Assignment of Lease Agreement was presented to the Board for approval.

A motion was made by Member Lovelace and seconded by Vice Chairman Hunt to adopt the Resolution of Assignment of Lease Agreement which authorized the transfer of Hangar 3A and 3B from Philip O'Reilly to Casey Keating, thus waiving its right of first refusal and is contingent upon the execution of a binding Assignment of Lease Agreement and any corrections that may be required. A RESOLUTION AUTHORIZING ASSIGNMENT OF LEASE AGREEMENT

WHEREAS, the Rutherford Airport Authority ("Airport Authority") entered into a Lease Agreement with Mike Price dated June 22, 2011, for the premises known as Hangar 3A, and recorded in Book 2039 at Page 2484, Rutherford County Registry, and said Mike Price assigned the said Lease to Duncan Creek Properties, LLC, in that certain Assignment of Lease Agreement dated November 17, 2020, recorded in Book 2039 at Page 2499, Rutherford County Registry; and

WHEREAS, the Airport Authority entered into a Lease Agreement with Mike Price dated June 22, 2011, for the premises known as Hangar 3B, and recorded in Book 2039 at Page 2519, Rutherford County Registry, and said Mike Price assigned the said Lease to Duncan Creek Properties, LLC, in that certain Assignment of Lease Agreement dated November 17, 2020, recorded in Book 2039 at Page 2534, Rutherford County Registry; and

WHEREAS, both the Lease Agreement for Hangar 3A and for Hangar 3B were assigned to Phillip O'Reilly in that certain Assignment of Lease Agreement dated December 29, 2022, recorded in Book 2069 at Page 403, Rutherford County Registry; and

WHEREAS, said Assignment of Lease Agreement recorded in Book 2069 at Page 403, Rutherford County Registry, requires a correction instrument to correct certain references and misspellings and to clarify the disposition and conveyance of the interest of Duncan Creek Properties, LLC, and

WHEREAS, Section 12 of the Lease Agreement for Hangar 3A recorded in Book 2039 at Page 2484, Rutherford County Registry, allows Lessee therein to assign the full rights under the said Lease Agreement upon the written consent of the Airport Authority, and states that such consent shall not be unreasonably withheld, as well as provide for right of first refusal by the Airport Authority to purchase any improvements and buildings built thereon; and

WHEREAS, Section 12 of the Lease Agreement for Hangar 3B recorded in Book 2039 at Page 2519, Rutherford County Registry, allows Lessee therein to assign the full rights under the said Lease Agreement upon the written consent of the Airport Authority, and states that such consent shall not be unreasonably withheld, as well as provide for right of first refusal by the Airport Authority to purchase any improvements and buildings built thereon; and

WHEREAS, Lessee Phillip O'Reilly now wishes to assign his full rights under both the Lease Agreement for Hangar 3A and the Lease Agreement for Hangar 3B to Casey Keating for the consideration One Hundred Twenty Thousand Dollars (\$120,000.00).

NOW, THEREFORE, BE IT RESOLVED by the Rutherford Airport Authority, that:

The Airport Authority consents and authorizes Phillip O'Reilly to assign his rights under the Lease Agreement for Hangar 3A recorded in Book 2039 at Page 2484, Rutherford County Registry, and the Lease Agreement for Hangar 3B recorded in Book 2039 at Page 2519, Rutherford County Registry, to Casey Keating contingent upon the execution of a duly binding Assignment of Lease Agreements for both Hangar 3A and Hangar 3B in the general form attached hereto as Exhibit A; and

The Airport Authority chooses not to exercise its right of first refusal to purchase home improvements and buildings constructed on the premises of Hangar 3A nor of Hangar 3B set forth in the Lease Agreements referenced herein. The waiver of each right of first refusal is effective only as to the specific transactions referenced above and any and all such rights in both Lease Agreements referenced herein are specifically reserved as to all other transactions and parties.

The Airport Authority does also authorize the Chairman, working with the Airport Director and County Attorney, to execute such documents as necessary to correct any prior Assignment of Lease Agreement for Hangar 3A and Hangar 3B in recordable form.
