##### **A. ID-25-4347 Third Agreement to Amend Conditional Agreement for Purchase and Sale of Real Property (Project Quiet – 47.43 Acres located on Daniel Road)**

Economic Development Director Birgit Dilgert told the Board that the County currently has a purchase and sale agreement with a developer, Quiet Creek Properties, LLC, who is proposing a new housing development on the county owned property on Daniel Road. The current contract closing period is December 19, 2025. If approved, this amendment along with a \$50,000 extension fee, extends the closing period until May 19, 2026.
