Shingle Removal:

 Remove necessary shingles around the two existing roof hatches to allow for proper curb installation.

• Wood Curb Installation:

- o Construct and install a wood curb around each roof hatch.
- o Ensure the curbs are properly step-flashed to maintain waterproofing and roof integrity.

• Fabrication and Installation of Covers:

- Fabricate custom covers for both curbs.
- o Design covers to be easily removable for access to the original hatches.
- o Install covers securely over the curbs.

• Decking Inspection and Repair:

- o Inspect the decking around the work area for any signs of rot or damage.
- Replace or repair any rotten or damaged decking before proceeding with curb installation at a unit cost of \$6.00/Sqft
