I. Call to Order

Chairman King called the December 2, 2024 meeting of the Rutherford County Board of Commissioners to order.

II. Public Comments

Mr. Pat Chamberlain, founder and executive director of Out of the Ashes told the Board that this organization provides support for over 300 individuals each year. It operates without any county, state, or federal funding, and the need continues to grow. He asked that the Board consider what the community would do if this resource was not available. The organization creates lasting changes in those they serve.

Mr. Michael Dalton saluted all veterans, law enforcement, and those who worked hard during the Hurricane Helene disaster. He reminded the Board that he had been addressing County issues which mainly involved opposition to zoning and imminent domain since 2002. The past three boards had not required his input on these issues, but he is prepared in case they should arise again.

Another issue troubling Mr. Dalton was a group in Rutherford County that has a closed Facebook page and had made accusations at a recent County Commissioner meeting. If they have evidence to support the accusations, Mr. Dalton said these should be presented to law enforcement.

A. ID-24-3986 Rutherford County Awarded \$25,000 Grant from Duke Energy for Swift Water Rescue Equipment

Mr. Craig Debrew, Duke Energy's Local Government and Community Relations Manager, announced that the Duke Energy Foundation had awarded a \$25,000 grant to Rutherford County for swift water rescue equipment. The grant is part of a \$2.2 million commitment from Duke Energy and its Foundation to support disaster readiness, relief and recovery across North Carolina, including support for mountain region communities impacted by Hurricane Helene.

B. Sole Source Request Detention Center - Millennium Access Control Technology - MPACS 200 Frame and Tray Assembly, with Paracentric Locks and Keys

Finance Director Roach advised that the Detention Center staff submitted a request for Commissioner consideration that a Sole Source Purchase and competitive procurement be waived as allowed under NCGS 143-129(e)(6) exemption which states: *Purchases of apparatus, supplies, materials, or equipment when: (i) performance or price competition for a product are not available; (ii) a needed product is available from only one source of supply; or (iii) standardization or compatibility is the overriding consideration. Notwithstanding any other provision of this section, the governing board of a political subdivision of the State shall approve the purchases listed in the preceding sentence prior to the award of the contract.*

Detention staff has advised that Millennium Access Control no contact food port system is the best product/solution for their facility. The current traps on cell doors are severely rusted and damaged beyond repair. To mitigate this, barrel bolt locks with padlocks were added to secure the traps and prevent inmates from tampering with or opening them. Installing new trap attachments will eliminate the need for padlocks on the PODs, which could otherwise be misused as weapons. This upgrade will also address the issue of items and bodily fluids being thrown at officers and other inmates, creating a safer and more secure environment. Additionally, the new traps will allow food trays to be passed through a secure port, minimizing direct contact with certain inmates.

J. ID-24-3974 Designation of Child Fatality Prevention Team/Community Child Protection Team (CFPT/CCPT), Future Local Team, as a Single/Multi County team

Social Services' Director Delores Hunt said the the NC Child Fatality Prevention System is a statewide multi-disciplinary system that was developed in the 1990's consisting of the North Carolina Child Fatality Prevention Team, North Carolina Child Fatality Task Force and local teams (CFPTs and CCPTs).

N.C.G.S. 7B Article 14 defines the membership composition of CCPTs and CFPTs, statutorily required to represent disciplines among the community, as well as the responsibilities and duties of the local CFPT to review resident county child fatalities, assess potential gaps in systems and policies that may have contributed to the deaths, and make recommendations to policy makers to improve local and statewide systems to better protect children and prevent future deaths.

Passed in 2023, changes to the law via the 2023 Appropriations Act [Section 9H.15 of Session Law 2023-124] now requires all Boards of County Commissioners to determine if the local team proceeds as a single or multicounty team. Director Hunt said Rutherford County would like to continue as a single county team and requests the Board of County Commissioners' confirmation of this operational model.
