Project Description: This proposal is to provide and install a new Edwards EDGE panel and devices, device-for-device, in the Maintenance Building. Haynes Technologies will provide necessary equipment, installation, and testing as required.

THIS PROPOSAL DOES NOT INCLUDE: Raceways of any type, mounting of special boxes, 120V power or surge protection, permits, lifts, firestopping, after-hours work, access panels/installation, removal of the existing recessed fire alarm backbox or can embedded in the masonry or block wall, demolition, cutting, coring, or modification of masonry, concrete, or structural wall assemblies, patching, repair, restoration, painting, or finishing of walls or architectural surfaces impacted by existing or abandoned recessed equipment, flush-mounting of the new fire alarm control unit into existing recessed enclosures not compatible with the manufacturer's listed backbox, fabrication or installation of architectural trim, decorative enclosures, or aesthetic finishes beyond a functional metal cover plate required to cover the existing recessed opening, relocation of embedded conduits or concealed wiring within masonry walls beyond termination at the new surface-mounted panel, coordination or work by other trades including general contractor, masonry, drywall, or painting services, correction of pre-existing or concealed wall conditions, etc.
